## Bust at Smokers' Emporium

In November of 2021 the Geneseo Police Department began receiving information that a business on Main Street was illegally selling e-cigarette products to minors. The Geneseo Police Department and the Livingston County Drug Task Force conducted an investigation that included undercover purchases of marijuana from the location.

On March 2, 2022 a search warrant was executed at the location. Seized at the time of the search warrant was approximately 50 grams of cannabis, 216 grams of concentrated cannabis, 45 THC vape pens and approximately 648 flavored Vape pens. Also seized were 3 illegal stun guns.

Members of the Geneseo Police Department arrested and charged 19-year-old Robert R. Eagan with unlawfully dealing with a child (a Class A Misdemeanor) and Unlawful Sale of Cannabis (a Violation). Eagan was issued an appearance ticket and given a future date to appear in the Village of Geneseo Court.

Livingston County Health Department representatives were present and cited the shop for selling to an underage individual.

The Livingston County Drug Task Force is comprised of members of the following agencies, the Livingston County Sheriff's Office, the Avon Police Department, the Caledonia Police Department, the Geneseo Police Department, the Dansville Police Department, the Mount Morris Police Department, the Nunda Police Department, the State University of Police at Geneseo and the Livingston County District Attorney's Office.
